Land to the east of the Park, the water meadows and the Blackwater Valley could be used, but not the Farnham Quarry, Riverside and land south of the bypass, Bourne Woods or Alice Holt. The tariff is agreed but not the extra tariff for Natural England. Capacity should be reviewed in the light of falling dog ownership.

16	12/06/2009	Philip Design Associates	Objection. Considers Avoidance Strategy is not the right approach. The SPA was introduced without consultation and measures should have been introduced beforehand. The Avoidance Strategy has resulted in a virtual halt to planning permission in the 5 km zone, and has almost bankrupted the firm. No proper assessment of how the policy (the Avoidance Strategy) is affecting the SPA and local SANG. The increased dog walking in Farnham Park has put extra pressure on the wildlife in the Park. Developers do not object to paying a tariff as long as it is proportionate and reasonable. Natural England should itself fund work in the SPA.
17	17/06/2009	Mr S Smith	Objection. Where is the evidence that the Farnham Park SANG has taken any pressure off the SPA? The infrastructure cannot cope with more development that would result from the Avoidance Strategy. There is no commitment to support the principle of "local decisions by local people". Commitment to protecting Waverley Lane and South Farnham. Developers want to make money - who should the local council and government be listening to.

18	17/06/2009	Gail Kyle	Priority must be given to building outside the 5km zone in accordance with the SE Plan. SANG doesn't attract people from the SPA. The Local Plan doesn't protect the residential areas from over development such as over priced flats. The Avoidance Strategy will increase more garden grabbing, the Council is putting the interests of developers before residents. The Miniplan gave permission for 567 dwellings in 2 years more than the target for the whole of Waverley. The park will be urbanised.
19	17/06/2009	Mrs A Smith	Objection. Farnham is already congested and cannot keep on bringing more residents and blocks of expensive flats. No proof that Farnham Park is taking away pressures from the heath and it cant be proved. Cant keep putting more and more people into a finite space without pressure on the infrastructure and environment.
20	17/06/2009	Carmel Dolan	Objects to the Avoidance Strategy. Permission given for 567 dwellings in Farnham, twice the housing target. Flats are inappropriate, what is needed is houses for families. Some houses in south Farnham have been demolished for flats, such as in Shortheath Road. The Local Plan does not protect the residential areas, and the infrastructure cannot cope. Waverley is putting the interests of developers before residents. There will be more garden grabbing. The Park will become more urbanised.
21	18/06/2009	Margaret Grant	Strongly objects to the Avoidance Strategy. Any more development will change the treasured place for ever. The new housing is not affordable homes for families, and they will add to the already overloaded infrastructure. Constantly trying to stem the tide of traffic parking overfull schools. More people will take away the environment, a pleasant place to live, parks to relax in, and the little wildlife left.
22	18/06/2009	Mr and Mrs Paris	Objection. The Local Plan does not protect unique residential areas from over development. Flats have been built at the expense of lovely houses of character in original plots, such areas need protection. There is not the infrastructure to cope with more development. Rail and public transport is poor. The Avoidance Strategy will generate more garden grabbing and Waverley is putting the interests of developers before residents. Developers can build outside the 5km zone. As a result of the miniplan 567 houses were granted in 2 years, more than the target for the whole of Waverley. Any alternative site for SANG would have the same result for Farnham.
23	18/06/2009	Mr and Mrs DH Cooper	Policy is wrong because it conflicts with SE Plan Policy NMR6 "Priority should be given to directing development to those areas where potential adverse effects can be avoided without need for mitigation measures." Waverley does not have to provide mitigation it is the responsibility of developers. Housing should be outside the 5km zone, as was the view of the Inspector at the previous Core Strategy at the Examination in Public (this did not take place). Object to the statement on the website that the updated plan is designed to continue to protect rare birds - not proven.

The Local Plan does not protect unique residential areas. Development has been high priced flats at the expense of houses of character. The infrastructure cannot cope. Rail and public transport is poor. There will be more garden grabbing. The east access to the Park is unsuitable. There is no proposal to protect the SPA. Waverley is putting the developers before residents. 567 dwellings in 2 years, more than the target for the whole of Waverley
25	19/06/2009	Chris Hunter	Objects to the idea of using Farnham Park to offset surrounding heath use. Dog walkers will use the area nearest to them. The Park will be damaged by increased use because the pond /waterway system is vulnerable to pollution and over use and there are newt colonies, protected by law. The archaeological sites can be damaged by an increase in use and other wildlife suffer when there is too much disturbance. There is an area of chalk downland which is just as sensitive as heathland. There are already problems from the existing number of users.
26	19/06/2009	Max Lyons	Doesn't agree with the Avoidance Strategy. Housing should only be outside Zones A and B.
27	19/06/2009	Art Bay Ltd	Objects to new extended proposals. With the Park as a SANG it is overfunded. New building in the surrounding areas needs to be much more strictly controlled, then there would not be a need for an Avoidance Strategy.
28	19/06/2009	Trevor Larking	Objection. The area south of the railway station is saturated with traffic due to building. The schools are oversubscribed and further housing will result in further demands for schools parking and other facilities. Constantly get involved in traffic jams. The additional housing, including East Street will create further congestion and overloading of the infrastructure.

29	19/06/2009	Eric Dorling	Object to the extension of the Avoidance Strategy. Where is the evidence that the first designation (of the Park as SANG) has worked? Farnham cannot cope with a further increase in population. There is no spare capacity in the schools, the roads are jammed, pollution levels are dangerously high and there is no western bypass. The town is bifurcated, so the argument that the Park will attract walkers from the south is even more specious. Is Waverley turning a blind eye to traffic because it is the concern of SCC?
30	19/06/2009	Holdthatthought	Objects to the proposed Avoidance Strategy
31	20/06/2009	Jenny Johnson	Objection. The EU directive states that there must be no new development within 5 km of heathland. The infrastructure cannot cope. It is difficult to find places in schools. There are traffic problems and public transport is poor. The SE Plan did not expect any of the targets to be met within the 5km zone. There have been 567 dwellings in 2 years more than the target for the whole of Waverley and many have been high priced flats not affordable houses. The character of the Park should not be changed nor the historic character of Farnham. The Council is putting developers before residents.
32	20/06/2009	Michael Sweeting	Objection to the Avoidance Strategy, which builds on the Miniplan. Developers should be directed to build outside the 5km zone to support rural communities. No evidence that the SANG attracts people from the SPA. The Local Plan does not protect the unique character of residential areas from overdevelopment which has been mainly high priced flats at the expense of larger houses of character, such as the Borelli and Falkner legacy. The infrastructure cannot cope. There is no protection for the SPA itself. The SE Plan stated that it did not expect targets to be met within the 5km zone. The Park will be urbanised. Any alternative SANG will mean the same result for Farnham.
33	21/06/2009	John Bowden	Objection. Huge concern about building further houses in South Farnham. Already feeling the effects of overdevelopment. There is over demand for parking at the station. Already being ruined for example The Ridgeway. Roads are congested and schools do not have the facility to accept more pupils.
34	21/06/2009	Alison Molan	Objection. Build outside the 5km zone. No evidence that the SANG attracts people from the SPA. The Local Plan does not protect the unique character of the residential areas. Development over the last 2 years has been high priced flats at the expense of houses of character. The infrastructure cannot cope. Public transport is poor. There will be more garden grabbing. The proposed eastern access is unsuitable. There is no proposal to protect the SPA. Waverley is putting developers before residents. Developers can build outside the 5km zone. The SE Plan stated it did not expect any housing targets to be met in the 5km zone. 567 dwelling have been built in 2 years more than the target for the whole of Waverley. The Park will be urbanised. 36	22/06/2009	MJ Coomber Associates	Objection. The Avoidance Strategy is probably the only approach to avoiding adverse impact on the SPA. Any of the suggested alternative SANG would be acceptable. Haven't identified any other areas. Developers will have to pay the tariff but under no circumstances should they pay any fees to Natural England. The whole business of the SPA is quite unacceptable, but Waverley has done its best to mitigate the problem and are to be congratulated.

38	22/06/2009	Charlie Killen	Objection. The proposals will increase the number of inappropriate flats in a gardened town already losing its character. Resources should be dedicated to development for families. There are already objections to flats so why waste resources on the Avoidance Strategy.
39	23/06/2009	John Trillwood	Objection. 567 new houses in 20 months, which is twice the annual housing target for the whole of Waverley, and are mainly luxury flats not affordable homes. Large family homes have been demolished and there is garden grabbing taking place, both leading to changes in the character of Farnham.
40	24/06/2009	Peter Thomazin	Objection. The proposed SANG won't have any bearing on the SPA. The development this would make way for in South Farnham is not matched by the infrastructure required to support an increased population. No justification for allowing further development in the 5km zone. Scope exists outside without the Avoidance Strategy.
41	26/06/2009	Dr P Lambert	Objection. Opposed the Miniplan and 567 houses were allowed. This new increase would allow 800 houses. The additional population would threaten the heaths. Changes in Farnham Park will not protect the heaths, it would just spoil another piece of natural Farnham. Increases in housing are pressurising the services. Traffic has increased and schools are overcrowded. There is garden grabbing and replacement of family homes by flats. Homes for first time buyers are needed. The Local Plan 2002 should be updated.

42	30/06/2009	Bourne Residents Association	Objection. Could find no scientific paper that justifies the case for SANG, and therefore it is rejected and dismiss any extension of the policy and the proposal that there should be a tariff for the work of Natural England. Concerned about the expense of public money.
43	29/06/2009	South Alliance Investments	May need to seek consent for conversion of offices in West Street to three one bed flats. Willing to pay the tariff.
44	30/06/2009	The Farnham Trust.	Objection.Does not believe the Avoidance Strategy is the right approach because of the damaging effect on the Park. The use of the Park as SANG is a form of commercial exploitation which is a threat to its integrity and character. The Avoidance Strategy will lead to high density residential development in South Farnham, leading to the loss of family houses and spacious gardens and their replacement with high density units and flats. This would result in damage to the character of the area, a considerable net increase in population and would affect the Park. The Park must be protected from high density use. There are already restrictions on the SPA and there will be redirection of visitors to the Park. The Avoidance Strategy focuses on the Park as SANG. The other option are dismissed or long term. The SE Plan NRM6 states "Priority should be given to directing development to those areas where potential adverse effects can be avoided without the need for mitigation measures." Cites the Waverley Farnham Park Management Plan and a 1991 document by the Trust.
45	01/07/2009	John Birch	Objection. A large part of South Farnham is affected by the policy but the residents do not go to the SPA or the Park. They go to the countryside to the south. They avoid the bypass. The distance to the SPA ought to be journey time. The problem is compounded by eliminating the three zones. Waverley does not have to consult Natural England on applications in the zone. The two zones means that applications in Hale and the Bourne are treated the same way. A large proportion of the SANG is accounted for by East Street, which is frustrating small schemes. If it doesn't go ahead the reserved allocation is particularly unfair on smaller developers. Supports the Avoidance Strategy if Council deals with applications more than 4km away on their merits. All the alternative sites are suitable. Suggests land to the west of Wrecclesham Recreation Ground. Developers should pay the tariff.
46	01/07/2009	Christopher Bean	Objection. Does not agree with the Avoidance Strategy. It has not been established that there is public support for building in the 5km zone. WBC has no obligation to provide mitigation or avoidance. Intensification of the Park would be damaging. The consultation is premature because WBC has not completed or consulted on the Strategic Housing Land Availability Assessment.
47	02/06/2009	Charles Stuart	Objection. Further flats and houses in South Farnham will run contrary to all the residents needs, who should control decisions. Traffic is already at blockage point. Garden grabbing is a massive problem, the essential character is gradually being eroded. The SE Plan stated that it did not envisage any targets to be met within the 5km zone. The Miniplan allowed over 500 dwellings in 2 years. Opening up to 800 dwellings is unfair. There is no evidence that the SANG attracts people away from the SPA. Building should be outside the 5km zone. The Park should not be urbanised
48	02/07/2009	Dr J Huddleston	Support. SPA has to be defended SANG seems sensible. Park should be made a nature reserve. Bourne Woods a no go as an alternative site. Quarry seems least spoilable. Developers should pay for SANGs works and refund SPA costs to Natural England. SANGs facilities should be severely minimal.
49	02/07/2009	Derek Dunton	Objects strongly. Farnham being targeted by developers and 567 dwellings have been approved in 2 years. The SANG is just a means of allowing more houses and the Park is being abused for this purpose. The infrastructure will be unable to support the increased population, garden grabbing will continue.
50	02/07/2009	Fand M Davies.	Objection. Opposed to WBC effort to circumvent EU Regulations by seeking to increase use of the Park, and find it too busy already, so people will go to the very areas being persuade to avoid. Don't agree with the Avoidance Strategy let the developers do their own legwork. Alternative sites not suitable. Developers should pay the tariff and the extra tariff to Natural England. WBC should not be involved in this exercise.
51	03/07/2009	Mrs S Watson	Objection. No further building should be allowed within the 5km zone. The SE Plan did not expect any of the targets to be met within the 5km zone. There is no proposal to protect the SPA. Adding to the SANG will make the Park urbanised. There is no evidence that the Park attracts people from the SPA. The proposed eastern access is unsuitable. Any alternative site would mean the same result for Farnham. 567 dwellings have been approved in 2 years. This is twice the housing target for the whole of Waverley and they have been high priced flats at the expense of housing of character. The infrastructure cannot cope and public transport is poor.

52	04/07/2009	J and D Thorpe	Objection. There is no legal requirement for the Council to provide alternative green space, it is the obligation of the developer. Alternative sites should be sought throughout the Borough. The whole issue needs to be reconsidered.
53	06/07/2009	P and P Marriott	Strongly object to using Farnham Park as a SANG to allow developers with WBC support to continue building houses in the area. The EU Directive requires an Appropriate Assessment for development that would have an impact on the SPA. What is the status of development where there has been no AA. How could Natural England give support without the AAs. Independent consultants should have been used to decide if mitigation measures are acceptable. EU legislation requires that new recreational land be used. Farnham Park has always been accessible to the general public. Improving the car parks does not constitute the provision of new recreational space. Non compliance with the Directive would open WBC to legal challenge. Developers are responsible for mitigation measures but WBC has to ensure that the appropriate legislated requirements are met before planning approval is given. Mitigation measures require a cumulative approach and have to take account of all developments that have been completed since the Directive was introduced.
54	06/07/2009	Castle Street Residents Assoc	Objection. Do not agree with the Avoidance Strategy. The provision of mitigation is not the responsibility of WBC it is the responsibility of the developer. Do not agree with the alternative sites or the two tariffs. The consultation is premature as WBC has not yet consulted the public on its proposed future housing development.
55	06/07/2009	CW and BA Wicks	Objection. Twice the number of houses for Waverley have been granted in 20 months so there is no more room. There are more appeals waiting. The Tilford and Waverley (Lane) are blocked and town centre. The services are overstretched. Why does Farnham require more housing, the people of Farnham do not. Why does WBC persist in trying to cram more houses into Farnham?
56	06/07/2009	D and J Huddleston	Objection. Do not agree with Avoidance Strategy. Regional policy says developers should be offered areas where unwanted effects don't require mitigation. In January 2008 the Waverley barrister said at an Inquiry that WBC had already met its housing targets for quite a few years. The Avoidance Strategy will encourage garden grabbing. WBC has not shown that Farnham Park has received more dog walkers, so could be in contempt of the EU law. The park should be left to birds, newts and casual walkers. The quarry is likely to suffer least from being a SANG and may benefit. (Regarding other possible SANG)has WBC shown that a SANG is inescapable - where is the evidence- where is the Strategic Housing Land Availability Assessment. Agrees with the tariff. Developers should pay for infrastructure and the tariff for Natural England. An excessive house building quota is being unfairly imposed on Farnham
57	06/07/2009	Christine Bean	Objection. Does not agree with the Avoidance Strategy. Provision of mitigation is the responsibility of the developer. WBC has no legal responsibility to provide mitigation and should not assist developers to build in the 5km zone. Does not agree with the tariff for mitigation. The consultation is inappropriate and premature. It assumes that WBC has already decided that Farnham can accommodate at least 540 houses within the 5kmzone, although it has yet to complete and consult on a Strategic Housing Land Assessment.
58	09/07/2009	Derek Wilson	Objection. WBC has not set out what recreational uses it intends to foster in the Park - is it to be a recreational centre? The proposed developments of areas contiguous with the Park such as in Rushmoor have not been taken into account and these will increase the use and stress on the Park. WBC has not evaluated the impact that the current SANG designation has had on the Park or how it has protected the SPA. All development in the greater Farnham area should be frozen until WBC has analysed these issues.
59	07/07/2009	J Langdell	Objection. Does not agree with Avoidance Strategy. The provision of mitigation is the responsibility of the developer. All the proposed alternative sites should be protected from development. Has not identified other SANG which should be done by an environment study. Does not agree with the tariffs as disagrees with the principle. The consultation is premature and has been conducted in a vacuum without reference to other options in the Borough which should be considered first.
60	09/07/2009	Dudley Feather	Support. Agrees with the Avoidance Strategy. All the (proposed) SANG should be assessed for suitability. Proposes the army land north of Upper Hale as SANG. Agrees both tariffs. Farnham is an attractive location for development and there is not enough property to satisfy the demand. The pace of development cannot be sustained. WBC must limit new development through planning control and tariffs etc.
61	09/07/2009	Pamela Pownall	Objection. The Miniplan and the Avoidance Strategy are not sufficient to guarantee the protection of the SPA. Have the measures worked so far? Was there an increase in visitors to the park? How many visitors were there before the plans? Do you know for certain that any increase in visitors reflected the same people who would otherwise have visited the SPA? What has happened to the protected bird species? How will nominating an eastern car park encourage more people to use the Park - those people that would otherwise use the SPA? WBC is acting in contravention of the SE Plan

62	09/07/2009	Ted Bonner	Objection. The Avoidance Strategy is not the right approach. Provision of mitigation is responsibility of the developers. Waverley Borough Council has no legal responsibility to provide it. Assent to assisting developers has not been established. Doesn't agree with alternatives or Avoidance Strategy in principle. Doesn't agree WBC should provide SANG. Consultation is premature and is based on assumption that distribution of housing has been determined without reference to other options.
63	09/07/2009	South Farnham Resid. Assoc .	Objection. Waverley Borough Council is contravening the SE Plan. There is plenty of opportunity for development outside the protected (5km)zone. Reference to Policy SP3 of the SE Plan. Farnham has to absorb 567 dwellings which is equivalent to two and a quarter years of Waverley's housing requirement. Town suffers pollution, traffic congestion, inadequate public transport, doctors and dentists overstretched, schools at capacity, children may have to go to Camberley to school. Not in line with sustainable development.
64	09/07/2009	Andrew Millet	Objection. Since April 2007, permission given for 567 houses in Farnham, more than twice the requirement for the whole of Waverley. Can the Council prove that there has been a significant increase in the number of visitors to the Park who would otherwise have gone to the heathland? If not no logical reason for new residents to go there, rather than the heaths.
65	10/07/2009	David Graham	Objection. There is no obligation on Waverley Borough Council to provide an Avoidance Strategy. It is up to developers to provide SANG. Disagrees with both tariffs - should follow policy and not allow further development within the 5km zone. No legal obligation on WBC to provide an Avoidance Strategy to benefit developers. No evidence that people will use the Park in preference to the SPA because of signing and additional parking. No scientific evidence of the capacity of the Park. It is not suddenly alternative green space. Waverley should stop seeking to avoid the aims of the Directive and start behaving as a responsible LA. WBC is putting the future of the Park at risk overdeveloping Farham and doing next to nothing to protect the SPA.
66	10/07/2009	Mrs AC Graham	Objection. The Avoidance Strategy is not the right approach and Waverley Borough Council need not provide it. It is for developers to provide. Waverley Borough Council should not provide SANG and therefore disagrees with both the tariffs. The consultation is premature since WBC has not completed its SHLAA.
67	10/07/2009	KS Johnson	Objection. The Park was given by Farnham Urban Council for the enjoyment of the people of Farnham. It is an ancient deer Park with much history attached. Does not want to see it hijacked and urbanised by the addition of special pathways signage and car parks. Looks to WBC to protect the Park not to sacrifice it.
68	10/07/2009	Tim Cox	Objection. SANG availability and capacity firstly needs to be looked at on a sub regional basis in the context of the SE Plan. The actual demands on Farnham for housing need to be in the context of a Core Strategy, which would spell out the distribution of housing across the Borough. The Avoidance strategy is a device without a local planning context. The best way of protecting the heaths is to accept the minimum of essential development within the 5km catchment. Only if there are no viable alternatives elsewhere and some capacity would have to be found in the 5km zone should an Avoidance Strategy be developed. This is the approach of Regional Policy NRM6. In 2006 the Core Strategy failed on a similar point. The question of the alternative SANG or any other sites is premature. Agrees with both the tariffs once the need for a SANG has been established. Concerned that it is proceeding in advance of the Core strategy and the SHLAA. To do it this way opens the LPA to the charge that it is facilitating development with developer interests paramount as the amount of SANG available will determine the expectation.
69	10/07/2009	Robert Verner-Jeffreys	Objection. The Avoidance Strategy is unnecessary, undesirable and misconceived. It is not the Council's job to produce SANG or an Avoidance Strategy, they should come from a developer. Because of use of the Park as a ploy about 1200 extra people are living here in 20 months. Want no more expensive flats and gardens filled with rabbit hutches. The roads, surgeries, water, and sewerage, schools and hospital can take no more. Why not more cheaper homes in the villages and is the Dunsfold project not going ahead? Re the 5km zone is the Council talking to Rushmoor about what is happening in Church Crookham and Aldershot. The Park has been recognised by English Heritage. Let it be maintained and not urbanised.

70	10/07/2009	Virginia Immergluck	Objection. The Avoidance Strategy is not the right approach. It is the responsibility of the developer not the Council. Disagrees in principle and therefore with the alternative SANGs. The consultation is premature and is being conducted without reference to other options in the Borough which should be considered first.
71	10/07/2009	Judy Sauter	Support (qualified). Agrees that for the moment the Avoidance Strategy is the right approach, but the intended reduced impact on the SPA and the intended increased visitor pressure on the Park need to be monitored. It is an SNCI and is important for Great Crested Newts and deadwood for invertebrates. An up to date ecological survey is needed. (Re other possible SANG), parts of Farnham Quarry would be suitable but not the water meadows which flood and may be of wildlife interest and are part of the River Wey corridor and may be adjacent to a SNCI. Developers should pay the tariff for the SANG and these should be financed in perpetuity. Does not agree with the tariff for the SPA. The reduced visitor pressure should reduce the costs of maintenance. There should be a management plan for the SPAs and regular monitoring.
72	11/07/2009	Celia Sanders	Objection. Cites Policy NRM6. WBC should produce a SHLAA. No explanation of the need to allow further housing development prior to an Area Action Plan for traffic which should be a priority. 218		Natural England	Comments: Natural England confirms that, providing enhancement and monitoring measures are in place, the capacity of the Park can increase from 10.9ha to 21.25ha. Natural England accepts that the area adjacent to Six Bells Roundabout with the estimated capacity of 25 cars with the footpath link has the potential to attract extra visitors. However, the area must be clearly signposted. There should be monitoring of the Park as SANG from the main access routes to demonstrate an increase in use, as well as surveys to identify that visitors are using the Park instead of the SPA, from this access point created from the Six Bells area. The document could be shortened using web site references. Re alternative sites- the Quarry and Tongham Pools together provide an excellent opportunity for cross boundary working and strongly encourage Rushmoor Guildford and Waverley to negotiate. Supports use of the east side of the Park as a SANG. 7.4ha is on the small side but with its strategic position providing a 2.4km walk should be possible. If the whole of the site cannot be secured then a direct footpath should be secured. The current route from the eastern car park is not ideal. No knowledge of the Riverside and the south side of the Bypass, the water meadows or Bourne Woods. L

Pleased to see the in-perpetuity calculations being included in the tariff for the Park SANG. Supports the inclusion of the access management and monitoring tariff. Supports the monitoring of visitors to establish trends of use. Vital that the approach to visitor management assessment should be comparable to other areas. Has advised other LAs that an AA will be taken for the Core Strategy. Reference to the AA for the SE Plan and the Policy NRM6 would also be included within the Waverley assessment. If WBC accepts the view that avoidance strategies are measures designed to eliminate significant effects from housing development on the SPA then stating it within the document would help to meet the commitment as competent authority under the Habitat Regulations.
