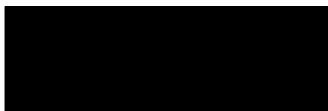

I write at the request of Mr Doherty of 1, Weeping Willow, Stovolds Hill, Cranleigh, Surrey, GU6 8UX.

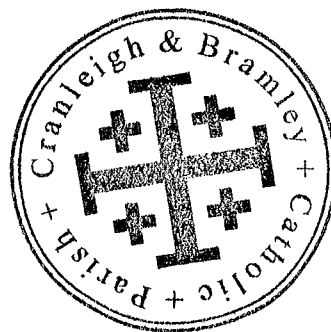
I am the Catholic Priest for the community of Cranleigh and Bramley within the Parish of Guildford and have been here since my appointment in July 2021.

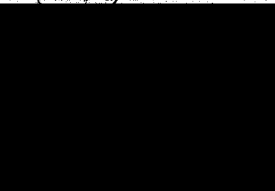

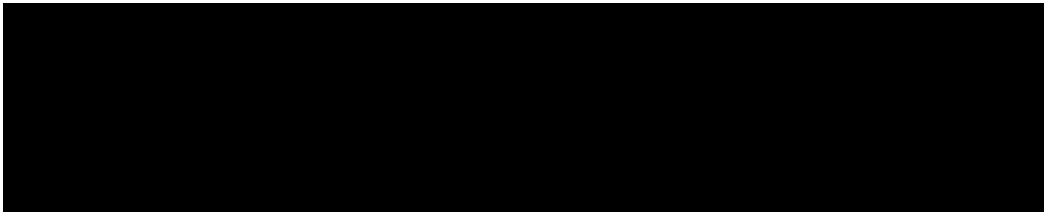

I have just seen your email which has been forwarded by Mr Doherty. The answers to your questions are as follows:
